IN CONSIDERATION of being permitted to enter upon, remain on, and explore the interior premises of the 125 year old former Mansfield Reformatory located at 100 Reformatory Road, Mansfield, Ohio, Releasor acknowledges and agrees the premises is without modern updating but consists of 19th century construction and architecture consisting of many multi-story, steep and narrow stairs, dark or low-light walkways, and safety hazards beyond the limited and restricted tourist access areas, and Releasor and his/her personal representatives, heirs and next of kin hereby releases, waives, discharges and covenants not to sue Mansfield Reformatory Preservation Society, Inc. (“MRPS”), an Ohio non-profit corporation, its officers and members, as well as promoters, sponsors, advertisers, owners and lessees of the premises and each of them, their officers and employees, all referred to as “Releasees,” from all liability to the Releasor, his/her personal representatives, assigns, heirs and next of kin for all loss or damage, and any claim or damage, on account of injury to the person or property or resulting in death of the Releasor, whether caused by the negligence of Releasees or otherwise while the Releasor is upon and within the MRPS premises.

Releasor agrees to indemnify the Releasees and each of them from any loss, liability, damage or cost Releasees may incur due to the presence of Releasor being upon or within the MRPS premises, whether caused by the negligence of the Releasees or otherwise.

Releasor assumes full responsibility for and risk of bodily injury, death or property damage due to negligence of Releasees or otherwise while in or on the MRPS premises.

Releasor agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Ohio and that if any portion of the agreement is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect.

Releasor, being of lawful age, in consideration of being permitted to enter upon, remain on, and explore the MRPS interior premises, does for himself/herself and his/her heirs, executors, administrators, and assigns, release and forever discharge all Releasees, their heirs, administrators, and executors of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of being upon or within the MRPS premises, whether by negligence or not.

Releasor further states that he/she has carefully read the above release and knows the contents of the release and signs this release as his/her own free act.

Releasor further releases all officials and professional personnel from any claim whatsoever on account of first aid, treatment or service rendered him/her while lawfully upon or within the MRPS premises.

This Release contains the entire agreement between the parties to this agreement and the terms of this Release are contractual and not a mere recital.
